**NOTIFICATION**

The state Government, in exercise of power conferred under Section 59 of the Tripura Police Act, 2007 (Act No. 6 of 2007), hereby establishes a State Level Police Accountability Commission ("~~the~~ **Police Commission**") consisting of the following persons as its Chairperson and Members, namely -

5. Shri Bimal Bhowmik, Retd Member of Indian Administrative Service and Ex-Commissioner & Secretary, Government of Tripura : Member


2. The term of office and conditions of service of the Chairperson and Members of the Commission shall be as provided in "the Chairperson and other Members of Police Accountability Commission (Remuneration, Allowances and other Terms & Conditions of Service) Rules, 2007" made under sub-section (3) of Section 62 of the Tripura Police Act, 2007.

3. The Commission will consist of such number of staff with such terms and conditions of service as may be prescribed by the State Government by notification in official gazette.

4. The Commission will exercise the powers, discharge the functions and enjoy the immunities as provided in the Tripura Police Act, 2007

This will come into force with immediate effect.
